LED Lighting Project to begin!

The Town of Belmont in conjunction with Affinity LED Lighting will be replacing 43 Street Lights in the Town of Belmont with LED lights. The Town received an energy grant through Eversource to assist with funding this project and we obtained lease financing for the project through Franklin Savings Bank. We look forward to the completion of this project in early summer.

Statistical Property Value Update

We will continue our annual shim and overlay process this year; a schedule of the roads has not yet been established but should be available shortly.

Our message to all Dog Owners is to remind you of the importance of picking up your dog's waste from property not your own. The town installed at three different locations, dog waste stations where you can obtain a plastic bag to pick up the waste and deposit it in the numerous garbage cans located in the Village.



What's Flushable or Not

We continue to stress the importance of the "Not everything is flushable", **please check out the "Do Not Flush!" list to protect your sewer and septic system.** A "Flushable" label does not mean it is SAFE for your septic system or the Town's sewer. Bulky Waste Disposal



Beginning Wednesday, September 2, 2020, and on the 1st Wednesday of each month following, Casella Waste will collect your bulky items curbside. Please note this is for Town of Belmont Residential Customers only; service is not available to commercial property owners.

Piles of debris, trash, yard waste or a single item too large for one person to collect WILL NOT BE ACCEPTED. A request for pickup must be made in advance by calling Town Hall at 267-8300, Extension 118 or 124 only. You will be asked to list the items you want picked up, you will be advised what the cost is, and you will need to drop off a check made payable to the Town of Belmont prior to the collection day. Town Clerk's Corner



It's that time of year again! The first issue property tax bills were mailed out May 20, 2022, this bill covers the time period from April 1st through September 30th. The amount of the first issue tax bill is one half of the total taxes paid in the previous year (2021). The taxes are due July 6th, 2022. You can mail your check in with your payment stub, stop by the office with your payment, or pay on our town website, www.belmontnh.org using either your checking account or a credit card. Please keep in mind that there are extra fees associated with using the online option as well as if you use a credit card. We will assume that you consider your returned check your receipt unless you bring in the top portion of your bill for us to stamp "PAID" in the office. If you are mailing in your payment and want a stamped receipt, please include the top half of your bill and a self-addressed stamped envelope, we will stamp the top half "PAID" and return it to you.

Residents with town water and sewer service will also soon see the 2nd issue Water/Sewer bills. The second issue bills cover the time period of March, April and May.

Dog licenses are due to be renewed by April 30th every year. Sometimes this task is overlooked so we send out reminder postcards in case it slipped your mind. In the month of June, a letter will be sent out to owners of unlicensed dogs by the Belmont Police Department mandating that we apply a \$25.00 civil forfeiture fee to each dog license that has not been renewed, per NH State law (RSA 466:13). There is also a late fee of one dollar per month (starting in June) that is added to the cost of the license. You can mail in your payment along with a self-addressed stamped envelope, stop by the office, or renew the license on our town website www.belmontnh.org. Let's get those dogs licensed as soon as possible!

2022 is a State Election year. Our office will be accepting candidacy filings for State Representative for the Republican or Democratic primaries OR for the Delegate to the **Republican** State Convention. The filing period is from June 1 – 10, 2022. **You must be a registered voter in the party for which you wish to be a candidate for.** An individual can stop by our office and fill out the proper paperwork and submit the filing fee of \$2.00. If you have any questions, please contact the New Hampshire Secretary of State's Office or our office.

Some important dates to remember:

- September 13, 2022 is the State Primary Election. This will take place at Belmont High School from 7 AM to 7 PM.
- November 8, 2022 is the General Election. This will take place at Belmont High School from 7 AM to 7 PM.

For those of you who are planning a summer wedding, we at the Town Clerk's office can provide your marriage license. The license costs \$50.00 and is valid for 90 days. Both parties must be present at the time of application. If either party has been married previously, you must provide the official, sealed document pertaining to how the marriage ended (divorce decree, death certificate, etc.) as well as your state issued identification. Couples also have the option of pre-paying for the marriage certificate, which is used to change your name, insurance paperwork, etc. The cost of the certificate is an additional \$15.00 and when we receive the completed marriage license back, we will print out the certificate and mail it to you. DPW News in June

Paving and Patching



The paving program for this summer is still in the planning process but since Hot Top plants have opened, your Public Works Department has been out patching and hand shimming some of the worst spots in town. There is more prep work involved in using hot mix than conventional cold patch but the finished product is greatly improved and has a longer lasting effect. Please pay attention to advanced warning signs and traffic control while traveling our roadways. Your crews are out there working every day. When you see them, say hi and let them know how they're doing.

Driveway Permits

Construction season is in full swing and The Department would like to remind everyone to acquire proper permitting, before having work done on your driveway. Starting a new construction, just grading and adding new material to a gravel driveway, paving for the first time or having an existing driveway repaved this permit must be completed and returned before you begin. The purpose of a driveway permit is simply to provide safe access to and from any town-maintained road in Belmont and protect the road itself. The permit process is usually quick, easy and has minimal fees attached. For any new construction, the department looks for a few things. First is Adequate sight distance in both directions, this is based on an equation that takes roadway speed into consideration. Second, is Proper drainage. The driveway may need a culvert pipe to carry water in any roadside ditches or swales past the driveway without interrupting flow. Size would be determined by topographical layout and existing drainage up and downstream. A pipe is not always necessary if everything on the property slopes away from the roadway. This determined on a case by case basis. The last piece to these permits is the apron. A typical driveway is 20 feet wide and as you approach the road the last few feet flare out about 5 feet on each side of the driveway creating a 30-foot access that touches the road. If the road is paved, we request that apron portion that stretches over any required culvert (usually 5 feet) is paved to protect the roadway edge from breaking away. Upon completion, a department representative will come out and sign off if all requested conditions have been met. Permits can be found on the town website and submitted to town hall.

Code Enforcement News

From your Friendly Code Enforcement Officer:

I hope you're having a wonderful spring and you are taking the time to take a look around your yard.

It's June! RVs are in use now! Please remember the following regarding RVs and your property.

- All RVs must maintain registration and inspection while parked on your property.
- You are allowed only one RV on your property. If you have taken delivery of a new one, make sure you are figuring out what to do with the old one.
- Vacant property cannot house RVs indefinitely. You are allowed 45 days on a vacant lot within a calendar year.
- ♦ If you have an abundance of scrap metal or junk on your property, there are numerous locally owned companies who will be willing to come get it. If you have junk, scrap metal, or a house cleanout to do, and need help finding someone to do it, I will be providing a monthly contact for local junk removal companies.

This month our featured Junk Removal Company is NH Junk Couple. They are a Veteran owned, husband-and-wife team, local to the Lakes Region and family orientated. Give Isiah and Natasha a call. No job to big or small.



- ♦ If you are zoned in Rural, or Residential areas, using cars, trucks, or vans as a storage container is not permitted. These vehicles need to maintain registration and inspection.
- ♦ If you are going to be doing spring clean-up, house renovation, or property clean-out, and require a storage container, make sure to get it permitted. Storage containers can not be permanent to your property and need an end date for them.
- ♦ I am still trying to track down new Belmont Businesses for Aquifer Inspection participation. If you are a new business, please reach out to me and we can get the process started. If you are an established business and have not had your inspection done, we need to talk.
- ♦ If you would like me to include your junk removal business in my monthly newsletter, please let me know. I am not advocating for any one company. I am simply giving property owners options and information.

What are Cyanobacteria?

Cyanobacteria (formerly known as blue-green algae) are photosynthetic bacteria that utilize the sun's energy but also behave as bacteria.

If you Observe a Cyanobacteria Bloom or Scum, please call NHDES at (603) 848-8094.

- * Do not wade or swim in the water, especially near surface blooms.
- * Do not drink the water; avoid drawing lake water.
- * Do not let pets or livestock into or near the water; dogs are especially vulnerable to toxic cyanobacteria.
- * Call NHDES to report a cyanobacteria bloom sighting.

Young Cemetery

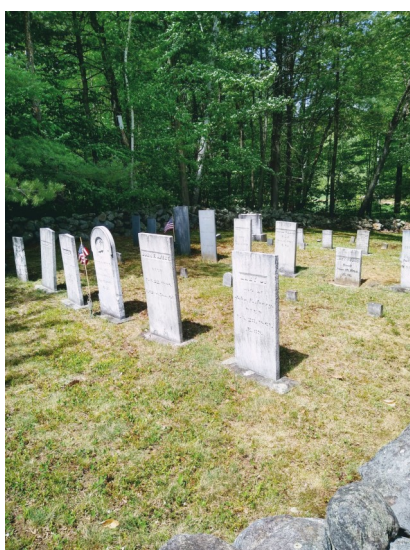
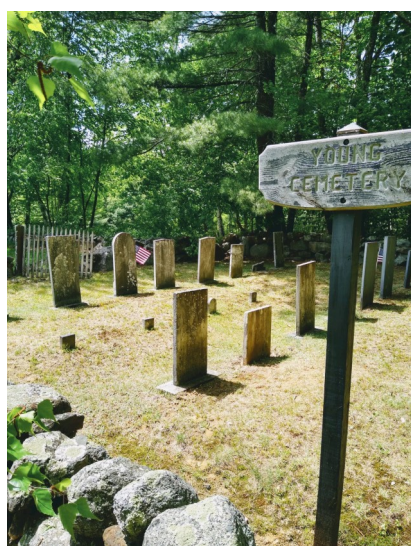
Memorial Day being just days ago we wanted to highlight Young Cemetery, located on Leavitt Road, across the street from Smith's Orchard it is the back half of the double rock walled area in the back yard of the White house. Under the beautiful canopy of trees around the perimeter several members of the Young family are laid to rest here.

The first being Andrew Young in 1805 age 10. Son of Eleazer Young who was a Revolutionary War Soldier. The last being Ann Marie Young in 1923.

A citizen of note buried here that we should mention is a young man named Ansel F. Young buried in 1863. Registered with the GAR as a Union Soldier with 15 NH Vol. Co. A enlisting on September 13, 1862. The 15th New Hampshire Infantry was organized in [Concord, New Hampshire](#), October 6–16, 1862, and mustered in for nine months' service under the command of [Colonel](#) John W. Kingman. The regiment lost a total of 161 men during service; 27 enlisted men killed or mortally wounded; 134 enlisted men died of disease. Ansel Young died from disease on May 14, 1863 in Carrollton Louisiana and returned home for burial. Believed to be Typhoid. We Honor him for his service.

There are 24 people buried here.

We have begun to inventory and catalog the historical artifacts and papers that have been gifted to the Society over the years so we can display them to help deepen the interest in our Town's history.

At the Province Road Meetinghouse we had the help of students from the Holderness School to scrape peeling paint and to burn brush. We also did touch up painting on the building's exterior and maintained the landscaping.

We are looking to the future as there is still much to be done to continue these projects and to reach the point where we can begin to rehab the interior of the Province Road Meetinghouse.

Since COVID hit, we did not ask our friends for donations or to renew their memberships. This year we once again ask for your membership and your donations so we can continue to work to make Belmont's history more accessible to the community.

Additionally, we invite you to become more involved with the BHS. We expect to present 2 programs this season, and we anticipate vacancies on our Board and certainly welcome you to participate in our ongoing projects.

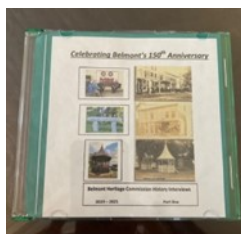

NEW HAMPSHIRE HOMEOWNER ASSISTANCE FUND FACT SHEET

Background	<ul style="list-style-type: none"> The American Rescue Plan Act of 2021 provided for the Homeowner Assistance Fund (HAF). The US Department of Treasury awarded the State of New Hampshire \$50 million to fund the New Hampshire Homeowner Assistance Fund (NH HAF). The State of New Hampshire, through the Governor's Office for Emergency Relief and Recovery (GOFERR), has contracted with New Hampshire Housing to administer the program.
Purpose	<ul style="list-style-type: none"> The program provides aid to eligible residents of New Hampshire who are struggling to pay their mortgage, property taxes, utility bills, and other housing costs during the COVID-19 pandemic.
NH HAF Assistance Provisions	<ul style="list-style-type: none"> NH HAF program offers three types of assistance, with maximum benefit per property of \$20,000: <ul style="list-style-type: none"> Mortgage Loan Reinstatement – funds for delinquent mortgage payments (maximum benefit - \$20,000) Property Charges Default Resolution – funds for delinquent property taxes, homeowner insurance, homeowner association or condominium fees/dues, and co-op maintenance or lot rents (maximum benefit - \$20,000) Utility / Internet Payment Assistance – funds for delinquent utility (electricity, gas, heating fuel costs, water & sewer, and internet payments (maximum benefit - \$3,000)
Loss Mitigation Requirement for Mortgage Loan Reinstatement	<ul style="list-style-type: none"> Eligible homeowners applying for the Mortgage Loan Reinstatement Program will be required to complete loss mitigation efforts with their servicer prior to receiving NH HAF funds. An exception clause is in place for those: <ul style="list-style-type: none"> Whose servicer has not been timely and responsive with homeowner's loss mitigation efforts; or Who have demonstrated imminent threat of losing their home, which makes it unlikely that loss mitigation can be completed in time; or Who for other good cause when other extenuating circumstances outside of the homeowner's control prevent completion of loss mitigation.
Form of Assistance	<ul style="list-style-type: none"> Cumulative assistance less than \$5,000 will be structured as a non-recourse grant. Cumulative assistance equal to or more than \$5,000 will be structured as a two-year, non-interest bearing, non-amortizing, forgivable grant with recorded note and mortgage. The grant is due in full upon sale, cash-out refinance, or transfer of ownership. If none of these events occur within two years, the grant will be fully forgiven, and the note and mortgage released.
Eligible Homeowners	<ul style="list-style-type: none"> Must have experienced a coronavirus pandemic-related reduction in income or increase in expenses that occurred after January 21, 2020 or began prior to but continued after that date; Must currently own and occupy the New Hampshire property as their primary residence; If a tax deed has occurred, homeowner must have an equitable, statutory, or other right to reclaim legal ownership and must still occupy the property as their primary residence; Must have income(s) of equal to or less than 125% of Area Median Income.
Eligible Properties	<ul style="list-style-type: none"> Must be owner occupied, or in the case of a land contract or contract for deed, occupied by the documented buyer, and include: <ul style="list-style-type: none"> Single-family (attached or detached) properties; Condominium units; 1 – 4 unit properties where one of the units is homeowner's primary residence; Manufactured/modular homes permanently affixed to real property and taxed as real estate; Manufactured homes not permanently affixed to real property but with a Title Certificate or Statement of Ownership in the homeowner's name. Ineligible: Vacant or abandoned properties, second homes and investment properties.

HOME PERFORMANCE WITH ENERGY STAR® Moderate-Income Program

The Home Performance with ENERGY STAR - Moderate-Income (HPwES-MI) program is open to qualifying customers of Eversource, Liberty Utilities, Unitil, and NH Electric Cooperative. The HPwES-MI looks to support those NH residents that are over income for Home Energy Assistance (income eligible weatherization program) yet may struggle to cover the customer co-pays in our market rate Home Performance program. HPwES-MI offers higher incentives on weatherization measures and 0% finance options to help cover the customer co-pay.

The program rebate structure is as follows:

OPEN HOUSE AT BELKNAP HOUSE FAMILY SHELTER - July 17th, 1-4PM

Belknap House is a non-profit LLC, located at 200 Court St and Union Avenue, Laconia and provides a temporary shelter for families in Belknap County facing homelessness. In addition to providing emergency shelter, it's mission includes empowering families to become self-sufficient, giving them a helping hand-up with customized resource referrals (social services, employment) and education (parenting skills, budgeting, etc.). This approach encourages struggling parents to work at developing needed life-changing skills and confidence and to find a permanent place in the community.

Belknap House was first organized from a community coalition in 2014 out of concern for homeless families in Belknap County. It opened in 2017 as a cold weather family-centered shelter but, when there was a 43% increase in family homelessness in the As of March 11th this year, Belknap House reached its fifth year of operation. The shelter has seen constant and extraordinary use in these five years and has providing 19,044 total bed nights of which 10,271 were for children, all supported by volunteers and generous donations from local communities and organizations.

To celebrate it's 5th year, Belknap House will conduct an Open House on July 17th from 1 PM - 4 PM.
