

Legislative Update





House Bill 1452 "relative to employees of public libraries" was voted Inexpedient to Legislate by a 13 - 7 vote.

House Bill 1615 – FN "requiring criminal background checks for persons brought into a library to interact with minors in library-sponsored events" was voted Inexpedient to Legislate by a 19-1 vote.

Both bills will be voted on by the full House later in the current session, and I will let folks know when that vote is scheduled.
