Messrs. Bulfinch and Mellen were
appointed a Committee to consider the
matter of foul atmosphere in the Library
caused by the water-closets in the
building and the pipes and drainage
connected therewith, and to take such
steps as they may think best, to remedy the same.

To facilitate the use of the Library
in our public Schools, -

Voted, that each teacher in
our public schools above the prima-
ry grade, be allowed to draw books
from the Library to the number of
five, to be used in the School as
aids to instruction.

No books shall be kept longer
than four weeks.

Each teacher shall be responsible
for the books, he shall draw for
School use.

The fines and penalties for
violation of these provisions, shall
be the same as in other cases.

A copy of our Catalogue and
Supplement, shall be kept in each
School building in which there are
schools benefitted by these provisions,
and such Catalogue and Supplement,
shall be in charge of the teacher
of the highest grade in the building.

Voted to adjourn to the 20th inst.
at 9 o'clock A. M. to make the
annual examination of Books,
and that the Library -

Committee, as prepared by the Secre-
tary in accordance with the
provision in the by-law, was
presented, and unanimously ap-
proved, and the Secretary instruc-
ted to have it printed, with other
town reports, as last year.

It was voted we ask the inhabitants of the Town at the Annual meeting next month for an appropriation of \$1300 and the Log Fund for 1879 to defray the expense of the Library and Reading Room for the ensuing year.

Messrs. Paton and Phillips were appointed a Committee, and instructed to have the back of the shelves on the first and second floor on the east side of the library, sheathed, also to have cord and pulley attached to window in north end of library (upper) so that it can be raised and lowered from the first floor.

Meeting adjourned for two weeks - 22^d inst. at 7⁴⁵ P.M.

Lane and Dr. Bulfinch be a Committee to confer with the Librarian in regard to classifying and cataloging the Pamphlets in the Library, and that they be authorized to adopt such measures as they deem best, in regard to having the work done, procuring Cases, and drawers for the cards &c.
