Aug. 1910 new bungalow of Arthur D. Rotch. In 1944 sold to Anna Haas. Belonged to Richard ^{Carter} in 1962. 1966 to Dr. Jan Tigchelar, owner in 1970 (1996).

ADAMS STREET

No.34(old #10)

1914 A.W.Wilkins house was built. In 1970 occupied by his daughter Mrs. Roland Rivard. Taxed 1967 to Heirs of Hilda Wilkins

ADAMS STREET

No. 38 (old #12)

1895 Fred Hutchinson's new house built - taxed to him in 1913

By 1939 occupied by Merritt Langdell - owner in 1975.

1927

ADAMS STREET

No.42(old #14)

1898 Charles B. Dodge new house, cellar by Stevens & Lovejoy
builder, Winters. May 1920 Edward Fifield bought. 1937 Fifield
house given to Baptist Church. In 1943 Harland H. Holt purchased
and in 1963 sold to the Congregational Church for a parsonage.

ADAMS STREET

No. 50 (old #20)

Dr. Howard S. Lawrence house sold before 1927 to Leon
Junkins. Dr. Lawrence taxed in 1922. In 1957 belonged to
Donimic D'Ramio, the owner in 1970. Owner 1973 Joseph Landers.

ADAMS STREET

NO.57(old #23)

In 1967 Edward + Katherine Thane were taxed for a lot from Goldman and built a house soon after. Sold 1972 to Gordon + Beverly Bowler, owners 1974. This was built on the ~~ex~~ extension of Adams to Dearborn which was built 1936.

ADAMS STREET

No.64 (old #22)

Built by Flanagan + purchased by Mr + Mrs William Roby who in 1953 sold to Mr + Mrs George Ingram who in 1955 sold to Pierre + Eva Bernasconi, owners in 1975.

ADAMS STREET

No.70 (old #26)

Built by Harold Remick in 1947-8. He is the owner in 1974.

AMHERST STREET

No 20 (old # 10) Not on map of 1854. In 1873 was owned by G.W. Duncklee, who had a store on Nashua St. He probably built the house. The land was once part of Abiel Holt's farm. Owned 1892. By 1927 taxed to Emma L. Wetherbee, wife of Dr. Fred Wetherbee who was a nephew of G.W. Duncklee, and still taxed to her in 1974.

Nov. 1916 Dr. Fred Wetherbee made extensive repairs to his house.

Aug. 1926 Dr. Wetherbee improving his house with a large piazza.

AMHERST STREET

No 26(old #14) David Heald house - built by David Heald who married in 1856. After his death owned by son Edward Heald. 1927 + 1938 Edward Heald Estate. David Heald owned both the Amherst St. + Forest St. houses in 1913. In 1942 taxed to Clarence David. Dr. Clifford Howland purchased in 1943 + before 1957 sold to the Catholic Church.

Built by David Heald and occupied by him until his death. He was there in 1873.

Sept 1916 Edward Heald moved to the David Heald house. 1913 taxed to David Heald Est.

1919 F.H. Richardson lived in the Heald House. Taxed 1942 to Edward S. Heald, Est.

1943 Dr. Clifford Howland purchased of Clarence David.

1952 Taxed to Dr. Clifford +Anna D. Howland.

1957 Taxed to Roman Catholic Bishop - also the house on
Forest Street, built by David Heald for son Edward.

AMHERST STREET

(old #15) was built as a shoe shop by Joseph Knowlton. (See pictures of Old Milford P. 55,56). Later moved here and used by his son Samuel Knowlton. J.R. Perkins built an addition to the second story. 1914 Thomas Garrity purchased. Owned by Dr. Homer McMurray when it was torn down in 1957 and a service station built.

(old #15) built as shoe shop by Knowlton and moved by son Samuel to the river bank. J.R.Perkins built an addition to second story. (one of the porches of the 1st town hall was moved there in 1846?) 1914 Thomas Garrity bought. Owned by Dr. Homer McMurray when it was torn down in 1957 and a service station built.

Joseph Knowlton came to Milford about 1780. Mr. Knowlton bought the west porch of the old meeting house, now Eagle Hall, and moved it to the east end of his residence (old #24) and used it for a shoe shop until 1836, when he sold it to S.D. Knowlton who moved it to the bank of the river. The "Red Shop" was for many years one of the "underground stations." Before 1850 it was a regular rendezvous for boys and young men. Demolished in 1884.

Around 1850 a syndicate of Dunklee, Holt, Powers and Horace Jones bought up land where Amherst Street houses No. 10, no. 14 and no. 16 are now located. (old street numbers) (See Milford Cabinet Sept 25, 1902.) David Heald purchased the Big Oak Tree lot (no. 14 lot) George Duncklee the lot the Wetherbee house is on no. 10, and a lady the Fuller lot no. 16.

This was once a part of the farm of Abiel Holt who came to Milford about 1794 and built a house on the site of the present Catholic Rectory (see Pictures of Old Milford p. 31,32) It must have been earlier because he enlisted from Milford in 1776. The Milford Map of 1854 gives Holt's Shop on this location. According to old deeds Abiel Holt lived at the corner of Grove and Summer Streets. He acquired a large farm on what is now Amherst, Summer and Dearborn Streets. He also bid on the making of pews for the

first church. "They were bid off to Abiel Holt to improve them six months and two weeks." In 1795 he was assessed a "Faculty tax." By 1804 he was one of the few who were taxed for a chaise. He died in 1834 "came from Andover, MA about the time of the incorporation of the town and was a carpenter by trade." His son~~4~~ George lived here when he married in 1841 but he left Milford in 1856. He was the one who sold to the syndicate who cut this farm into building lots and rented the old homestead to any tenants they could get until Andrew Fuller purchased it in 1864.

Andrew Fuller married in 1858 and lived here. June 13, 1876 Farmers Cabinet "Andrew Fuller is tearing down the old house and is erecting a large commodious residence with all modern improvements. The old house was probably the oldest house in town but one. The house will set back some 25 ft farther north than

the old one and about the same distance west. There will be a driveway between the house and barn. It is a hip roof house, Abiel Lovejoy, builder." In 1904 Mrs Harriet Fuller built an addition to the piazza on the south. In 1915 the Catholics bought the Fuller house and it is now the St. Patrick's Rectory.

AMHERST STREET

No. 42 (old #22) Mrs. O'Neil bought the smaller house of Finerty near the Catholic Church + Fred Trombly, the other. Trombly house torn down in 1935 when parking lot made.

Map 1854 gives Misses Kidder owners, also 1858. 1888 Edward Finerty purchased the Sam Goss estate and owned both Goss + Kidder houses in 1892 + 1900.

Mrs. O'Neil bought of Finerty and still owned in 1937.

1947 The O'Neil house taxed to Henry + Minnie Kirk.

Sept 1963 Edward + Caroline Kirk to Roland + ^{Gladys} ~~Gladys~~ Cloutier who were taxed for it in 1967.

No.46 (old #24)

AMHERST STREET

Joseph Knowlton came to Milford about 1780. Mr. Knowlton bought the west porch of the old meeting house, new Eagle Hall, and moved it to the east end of his residence and used it for a shoe shop until 1836, when he sold it to S.D. Knowlton who moved it to the bank of the river. The "Red Shop" was for many years one of the "underground stations". Before 1850 it was a regular rendezvous for boys and young men. Demolished in 1884. His wife died in 1834 and he died in 1842.

Map of 1854 gives S. Knowlton as the owner. Charles Wilkins purchased it around 1860. He died in 1888. Owned by his heirs, (Maria, Luella, Frank) until purchased by Mr.+Mrs Ernest Manley in 1968.

Taxed 1947 to heirs of Frank + Luella Wilkins.

Taxed 1952 + 1957 to Minnie Hoyle, a descendant of Wilkins.

1882 Charles Wilkins house improved by the addition of another story.

Sold by Minnie Hoyle, about 1960 to Ernest + Jean Manley.

They sold to Carl H. Roebuck, owner 1975.

No. 50, (old #28)

AMHERST STREET

1824? Samuel Knowlton was a shoemaker who resided in a house built by himself near his father's. His daughter Harriet (Knowlton) Fuller wrote that she was born in the cottage built by her father, Samuel Knowlton. (She was born in 1838)

1873 Robert Crombie owned by 1873.

1875 Henry Austin purchased a portion of the land and the house formerly owned by Robert Crombie. He was on the map for the place in 1892.

1901 map gives Hannah Chase (She was the daughter of Leonard Chase and Mary Dickey)

1910 purchased by Henry Wilson who sold

1913 to the Episcopal Church and is now their Rectory. That year the dormer windows were put in.

1921 new piazza added, ell raised to two stories and bathroom installed

AMHERST STREET

No.58 (old #30)

Not on the 1854 map. Asa Lyford came to Milford in 1882 and was taxed for this place in 1892. In 1916 his son-in-law F.J. Kendall sold to Miss Sarah Baker. It has had several owners since and has been added to and apartments made in 1950-1960s. Taxed 1967 to Orson H. Jr + Caroline Bragdon owners 1975. He has an office there and rents the apartments.

Abel Chase came to Milford in 1836, was a farmer residing on the farm formerly owned by Adam Dickey, the house standing where H.H. Barber now resides. He married in 1842 Hannah the daughter of Adam and Mary Dickey. p. 627 M.T.H. Adam Dickey was a farmer residing on spot where H.H.Barber's dwelling now stands. Married 1808 Mary Gordon of Peterboro. History p. 180 gives Adam Dickey living in 1822. P. 200 states that he was the first agent of the Milford Cotton + Woolen Man. Co.. That Co. was incorporated in 1810 - suspended in 1833 and in 1837 purchased by 4 Milford citizens P. 30 M.T.H. John Shepard built cabin little north of Methodist Church - later a house on spot now (27) Amherst and still later erected a more pretentious dwelling upon site now occupied by H.H. Barber.

H.H. Barber built in 1886 on this site. May 1935 it was

purchased by S.R. Goldman who still owns in 1967. Sold 1974
to George Wright.

May 1886 H.H. Barber purchased lot + buildings formerly owned by
Des. Abel Chase and John Dickey. Will remove the buildings and
build on the lot. House sold to Gilman Hartshorn for \$250.

(MOVED to Oak St.?)

AMHERST STREET

No. 62 (old #34)

Owned in 1854 and 1858 by Josiah Crosby who was a Civil War veteran who died in 1863 in Brashear City, LA while in the service of his country in the War of the Rebellion. His wife died in 1893.

1908 Will Richardson purchased the J.D. Crosby, Est., occupied many years by Dr. Eugene Wason. Oct. 1920 Mrs. A.W.Searles purchased. Taxed 1927 to Mrs. Carrie Searles.

1937 Georgianna Searles

1942 Arthur Searles

1951 Marion Smith

1968 owned by Mrs. Arthur Searles (Marion)

Many changes have been made during the years. Some corner posts and/are still there and some wide floor boards. The present

fireplace was built by Mrs. Marion Searles

AMHERST STREET

No. 67 (old #29)

This house was built on the site of the house of Col John Shepard who settle here in 1741. There is no record of what became of the house unless it was taken over by Chase and Dickey. The map of 1854 does not show a house on this location.

Fred Kendall came to Milford in 1882. He was a grocer and may have built this house. In 1909 Harry Shepard purchased the Kendall house. In 1944 his widow , Grace Shepard, sold to Paul Perham. Present owner 1975 is James J. Murray.

AMHERST STREET

No 70 (old #34 $\frac{1}{2}$) A 7 room house which was built by Barrett & Bugee - 1927. Owned by Victor H. Bugbee. In 1932 ^{Bungalow} ~~bugalow~~ owned by Building and Loan was sold to Wilfred Mitchell who owned in 1938, 1942?. Taxed in 1947 to Roland + Rita Boivert who still own in 1967. They are owners in 1975.

Built about 1927 by Bugbee for Dr. Oscar Burns.

AMHERST STREET

No. 73 (old #31)

Map of 1892 gives E.B. Lawrence as the owner. By 1900 it was the property of Jason Hutchinson and remained in the family until 1950 when it was purchased by Raymond Dyer who in May 1959 sold to Baker F. and Marion F. McNear, owners in 1975.

Not on 1854 map.

AMHERST

No.74 (old #36)

Map of 1854 gives George W. Royleigh as the owner. He was a wheelwright, also a veterinarian & surgeon who came to Milford in 1845. A Civil War veteran, he died in Goffstown in 1895.

No. 79 (old #35)

Maps of 1854 + 1858 give Joseph Cushing owner. He came to Milford in 1851 and died in 1879.

1883 purchased by C.H. Russell, owner.

1900 purchased by Charles Converse who was taxed for it in 1913.

1927 taxed to Eliza L. Converse and then owned by their daughter Agnes (Converse) Jewett in 1937.

1942, 1947, 1957 taxed to Robert C. + Susanne Holcombe.

1962 taxed to Harry R. Porter - sold 1970 to Mr + Mrs Dennis Lynch of New Haven, Conn. Sold to "Golden Toad" Duane Hammond?

AMHERST STREET

No. 84 (old #44)

1854 map gives J.D. Cochran who came to Milford in 1850 from New Boston. He was a carpenter. Died Milford 1888.

1895 owned by MRs. J.B.Fisher

1900 map gives J. Boutelle. In 1908 a fire did much damage to the house owned by the Boutelle heirs.

July 1917 George ~~Searles~~^{SEARS} has just bought the Fisher place. It needs much repairing after the fire.

1952 taxed to Mrs. Blanche ~~Searles~~^{SEARS} (Mrs. George)

Not on the map of 1854 or 1858. Maps of 1892 and 1900 give Mrs. Sarah Holcombe as the owner. In 1895 she raised the roof of the ell and made two apartments.

1903 Otis Brown of Nashua purchased the Holcombe house + Mrs.

Holcombe occupied an apartment. Brown owned until he sold to Gustave Brusquini who also owned in 1952.

1957 taxed to Gordon Soflin

1962 Jan + Mary Thunberg from Picconi. They owned 1967.

Directory of 1971 gives Mrs. Margaret Bushaw who owned in 1973.

AMHERST STREET

No. 90 (old #46)

Map of 1854 gives George W. Came - also owned in 1873

Sept 1883 Home of Capt. G.W. Came sold - a 19A 2 story brick building.

Jan 1886 Addison Knight purchased. The main part was brick and he replaced the wooden ell with a brick ell twice its length. He died 1887.

1895 Stella Clark ?

1913 Mrs. Estella (Clark) Haseltine until 1952 taxed to her daughter Mrs. Blanche Sears.

1961 Sold by Mrs. Blanche Sears to Miss Claire Himebaugh who will have a tea room and gift shop - called it the "Sugar and Spice".

August 1965 Sugar and Spice, Inc. to M P M, Inc. 1965 and

This was torn down and is now (1996) Longley Place.

There is some confusion as this was on the same card.

1881 Estate on Amherst St. occupied by J.W. Pillsbury for sale - a 2 story house with ell and barn connected.

No.118 (old#60) Not on the maps of 1854, 1892 or 1900.

AMHERST STREET - south side - torn down

There was a house on the bank of the Souhegan River on land now occupied by the People's Laundry (on the east side). I cannot find it on any map and do not know its origin or earliest owners. It may have been a part of Shepard's mills, later made into a dwelling house. I do know that Daniel Holt of Temple lived in the house from about 1840 to 1850 but do not know whether he owned or rented. The Tax Inventory of 1913 gives Charles Golby as owner; and he owned it until the Keyes Fund purchased it in 1940 and it was demolished. In 1913 it was valued at \$500, and 1940 for house and garage \$1000.

ARMORY ROAD

The only house given on the map of 1854 was the house built by John Burns III in the 1780s. He first built a log house but had a framehouse by 1790. On the 1854 map it belonged to John Daniels who had married a granddaughter of John Burns III. Owned in 1858 and 1892 by L.M. + J.M. Burns. In 1905 Willis Burns son of John M. Burns advertised for sale the Granite Hill Poultry Farm. In 1906 Stan (Starr, Stark ?) Ellenwood leased the farm and later bought it. In 1918 he sold to E.L. Kittredge. In 1931 Winston Kittredge completely ^{remodeled} ~~remodeled~~ it. Owner 1962 Mrs. Winston (Eleanor) Kittredge. She sold in 1963 to the Kitledge Granite Co. land and buildings. May 1866 Kitledge Granite Corp to Barretto Granite Corp. land and buildings. It is the owner in Dec 1975. Most of the old features are gone.

On the maps of 1892 and 1900 the only ^{two} ~~few~~ houses on the road were the Burns house on the north side of the road, and the George Pecker further west and on the south. In 1910 C.H.White on the Pecker place, 1913 John Boucher.

1912 Lovell Wright built near the South Milford station. Taxed 1911 to his wife Edith Wright. Owned in 1975 Lovell T. Wright, Jr. Taxed 1967 to Leona Wright Landon.

ARMORY ROAD

In 1915 Augustine Provasoli built. In 1954 he sold land to John Provasoli. Mar. 1920 John Boucher sold to Thomas Forsythe. In 1927 houses of Thomas Forsyth, Alphonse Jarest, Gustave Provasoli, Edith Wright, Est.

In 1937 houses of Thmas Forsythe, Thomas Forsythe, Jr., on the Jarest place, Gustave Provasoli, Lovell Wright.

In 1942 Thomas Forsythe, Sr + Jr, Winston Kittredge, Gustave Provasoli, Lovell Wright (1947)

In 1949 Miss Sarah Curtis permit \$4000 for new dwelling on the north side of road. She owned 1952 but in 1957 taxed to Marion Woodman. In 1962 taxed to Cornelius + Gladys Schneck who owned in 1975.

ARMORY ROAD

The map of 1854 has F.B. Hutchinson, McIntire's Soap factory and two buildings marked Moore but there is no street given so these may have been on Cottage Street. The directory of 1973 gives W.E. Alexander off Cottage and A.W. Steele off Cottage, but no Ash Street. Ash Street is marked on the map of 1892.
