LEWIS STREET

Land on this street had been cut up into house lots and sold at auction before 1913. ?? Aug. 1923 four new bugalows built for employees of G. B. Spring Co. The employees built them and will own later, but Spring assisted in financing. By 1927 Orion Patten had built and June 1939 his buildings were destroyed by fire. He rebuilt. Directory 1966 - house on corner under const. Victor Falcetti later built a house on the lot, Carol H. Brown (Not 1973), Leon L. Patten, Orion L. Patten.

This is not on the map of 1854 or in the Directory of 1873 except to mention the houses of Charles Lovejoy, Moses Ordway, Lyman Stone, farmer, and Charles Weaver.

In 1892 it was one of the houses owned by Levi McIntire, in 1913 taxed to Charles Needham, in 1927 through 1947 to James Casey. In 1954 Theresa M. LaFlame sold to Donald and Margaret J. Willette.

In 1961 Robert F. Willette built an outside stairway. In 1966 owned by Thomas Reece. Owner 1974 is Paul Silva who has made many improvements and rents apartments.
