SAVAGE ROAD - from Old Wilton Road

Map of 1854 gives William Jones on the farm settled by Caleb Jones in 1745 and occupied by his descendants until 1951 when the place was sold to Samuel Abbott of Wilton, owner in 197⁴ The original house was built on the hillside nearly opposite the brick house. This house was built about 1842 and still has several of its old features although there have been many changes.

The house was torn down during the 1990s and replaced by a Market Basket supermarket.

SAVAGE ROAD - FROM OLD WILTON RD

No. 36 the brick house was owned in 1854 by Jacob Howard who married in 1824 and died in 1889. the maps of 1892 and 190 give D. Wells Burns.

1905 Miss Nors F. Byard bought of Ulysses Burns the fine farm of 190 acres at the corner of Savage and Phelan Roads. The barn burned in March 1939 and never was rebuilt. M iss Byard's nephew owned by 1930. This was sold before 1932 by his heirs to Samuel Abbott.

SAVAGE ROAD - from Old Wilton Rd

The first house on the right belonged to Nathan Randolph Hutchinson in 1854. His father, Reuben Hutchinson, was probably the first settler on this farm which dates back to 1804, when Reuben Hutchinson married.

Charles Jenkins came to Milford in 1878 and lived here over forty years before he sold to Eugene Woodward in 1918. May 1959 Woodward sold to Samuel L. Abbott "two tracts of land in Milford, one of which has buildings" Land from this land was was purchased for Woodward Drive and its houses. Before 1962 Charles T. Zahn had built his house just north of Woodward Drive.

House at the corner of the Whitten and Savage Roads was owned by Zadock Jones, Jr in 1854. This was owned in 1892 and 1901 by
C.C. Shaw. It was unoccupied for many years and was called
Shoo-Fly Cottage by the people who lived in that vicinity.
Before 1917 Ernest Adams had bouth the place and eventually had built a large house and barn here.

1947 the place was taxed to Hentry Lamontagne.

1957 taxed to Arthur and Mabel Walmsley.

1974 owner was Arthur Walmsley. He improved the buildings. His step-daughter, Mrs. Donald Bruce has a mobile home just north.

The next place on the left on the 1854 map was the Jacob Rideout house and farm. This is not given on the map of 1892. Jacop rideout came to Milford in 1817 and died in 1863. None of his children took over the place. By 1966 Doris Jones and bought the site and placed a mobile home

upon it.

1973 She sold to Mark Gauthier.

No. 295 was the Amos Peabody place on the map of 1854. This may have been his father Aaron Peabody's place. Aaron came in 1767(?(and settled on the Mile Slip where he died 1826. Amos Peabody, son of Aaron, married in 1812 "and lived here until late in life". Map of 1892 gives J. Smith. 1892 map gvies Benjamin Bedell. 1927 Taxed to Frances Dickson. 1947 Taxed to Frederick A. Conrey, Jr. the owner in 1974. This place sets back ffrom the road.

The next house on the left was probably built by Isaac Burns who was married in 1827 and is given as the owner on the map of 1854. In 1854 John J. Savage came form Greenfield and that year or a few years later purchased this place. Maps of 1892 and 1901 give him as the owner. Later it became the

property of his son John F. Savage, and upon his death in 1939 passed to his son Ralph who died June 6, 1971. In 1974 belongs to his estate.

The next place on the right was the home of Jacob Rideout's so Abel Rideout on the 1854 map. Abel, who married in 1843 and moved away in 1854. The history of this house is given in the folder "Early Milford Homes" as the Phineas Blanchard House.

No. 387 Just a little beyond the Savage place but on the opposite side of the road is a house built by Ernest and Esther Adams about 1964. This is nearly on the site of the Landers Bros. house which was burned about 1912.

In 1854 the map gives this as the home of Willard Kendall.

SHEPARD STREET

No.8 (old #2) Built in 1924 for Ernest Rossi. Owned by him until his death in 1958.

1966 owner is Richard Chacos, owner in 1974.

SHEPARD STREET

No. 17 This house is beyond Olive Street. It was owned by Walter Salvail since about 1950 as he was taxed for it first in

1952. He is the owner in 1974.

(del#3)

SHEPARD STREET

No.20 (old #4) Built by Leroy Hathaway in 1960s. He is the owner in 1974.

This was a part of the Dean Moore farm which was purchased in 1890 by C.H.V. SMith for whom the street was probably named. In 1895-6 he erected houses No. 3 and 5 (old numbers). In 1903 he moved buildings that had started (or built) on the west side of Union Square. At the time the present town hall was built Luke Smith, father of C.H.V. Smith, purchased them and moved them to the bank of the brook on the site of the present WWII Memorial Garden. Then in 1903 they were moved to # 9 + 11 SMith Street and made into houses. (old numbers)

- No. 15 (old # 3) Was sold to Mary L. Rice to whom it was taxed in 1913.
 - 1918 She sold the house to Charles Clay who owned until his death in 1945(?).
- 1947, 1952, 1957 the place was taxed to his daughter and husband, Victor and Lillian Keskinen.
- 1962 taxed to Daniel Townsend. 1974 Owner was Alton Brooks.

- No. 12 (old # 4)Was made from a barn that C.H.V.SMith moved there before 1913(?) probably moved from Prospect Street when he purchased the Gilson Estate.
- 1927 taxed to David Rothovious and has been in the family ever since.
- 1974 owned by Andred + Sigrid Rothovious.

No. 11 (old # 5) Built by C.H.V. Smith in 1895-6. 1927 taxed to Rossi Bros. throught 1942.

1947 taxed to James P. and Frances Stevens who sold in 1955-56 to John J. Kirby, Jr. owners 1974

No.6 (old # 6) In 1927 Waino Kallio built this bungalow which he sold Sept. 1932 to Mr + Mrs. Edwain Salisbury, and was sold to Herbert Hall before 1947. ug. 1969 Jessie O'Brien sold the house for which she was first taxed

in 1952, to Norman and Elizabeth Bemis, owners 1974.

No.3 (old # 11) This is another of the houses moved here by C.H.V. SMith in 1903. It, too, was taxed to Charles Felli through 1942. 1947 Taxed to his daughter, Caroline Piotti,owner in 1974, but occupi¢ by her daughter Vella Bent.

SOUHEGAN

SMITH STREET

The building of the Souhegan Manufacturing Mills in 1848 brought Irish families to Milford. Seven years after the first Catholic family arrived, a missionary priest celebrated the first mass at the residence of Patrick O'Connor, in the presence of 30 persons. Land on Souhegan Street was given by John Finerty and Patrick O'Connor for the building of the first Catholic Church. (This burned in 1902 but had been unoccupies for 10 years). Houses were built by Irish families both east and west of the brick boarding houses which belonged to the Souhegan Man. Co. mills, as is shown on the maps of 1854, 1892 and 1901.

It has been difficult to trace the ownership of these houses, so I just give the list of owners as found in the Dictey Directories of Milford.

No. 3 (old # 3) is not on the map of 1854. "It is said to have been built by George E. Foster." He married in 1874 and his son was born in Milford in 1880. 1887 Rev. William Merrill bought the place.

1904 It was sold to a Mr. Baker.

1913 It was taxed to Patrick McFadden and in 1943 to Mrs. Annie McFadden.

1947 It was taxed to Arthur B. Hendrickson, owner in 1974.

(old # 4) October 1877 John Marvell who lately bought of H.S.Gilson the place on the corner of Amherst and Souhegan streets is making extensive improvemtns. He has purchased of Chase and Wadleigh land adjoining on th east 47 ft. front, running back 225 ft. upon which he has moved the large barn he purchased of Chase. He has sunk a well in the cellar and made an addition to the ell and put in a face granite wall next to the road on Amherst Street. This was originally built for N.W. Robinson who married 1973. The place is not on the map of 1854. Map of 1892 gives A.L. Harris as owner. Map of 1892 gives Herbert I. Bartlett, who also owned in 1913. By 1927 this was taxed to Charles S. Emerson who owned it until his death in 1952. Purchased 1953 by Edith and Ray Parker, owners 1970.

I believe this was torn down and replaced by apartment buildings.

No.11 (old # 5) Not on the map of 1854. Built by 1860, if not before by Alfred J. Lynch who came to Milford in 1856 and died in 1881.

1882 the A.J. Lynch house sold to George Worcester for \$1,465.

1884 he erected a towner 40 feet high for pumping water from the river to a tank in the top of his house which supplied him and his neighbors with plent of soft water. (Built on Eel Rock inback of his house).

1905 he built the piazza.

By 1927 it was taxed to his wife Mrs. Abaniah Worcester.

1937 +1942 It was owned by Mary Saunders.

1947, 1952 Taxed to Walter + Mary Reston

1957 Taxed to Joseph and Cecil Cullinan, owned by them 1974

No.8 (old # 6) Solon Kimball came to Milford in 1848 and built this house. It is on the map of 1854. He died in 1887. Maps of 1892 + 1901 give to Mrs. Fannie Kimball. Later owned by their son Willia Kimball and upon his death passed to his son Frederick Kimball. His widow, Katherine Kimball, sold in Sept 1867 to Richard + Barbara Fitzgerald, owners 1974.

o. 16 (old # 8) In 1846 Gilman Wheeler returned to Milford and lived at (old) # 8. He was owner 1854. Oliver Foster came to Milford in 1871 and probably bought the place then. He died 1917 and the place passed to his son GEorge Foster and it remained in the Foster family until 1955 when Lester Foster sold to Charles J. Monbleau. He was taxed for it in 1957.
1962 It was taxed to Abbott and Frances Potter.
1974 Owner was Frances Potter.

- No. 17 (old # 9) Not on the 1854 map. Owned by Salmon Sawyer until his death in 1872.
- 1887 Purchased by the Milford Baptist Society, through John Ober, for a parsonage.
 - 1940 It was solde to Ralph Arrighi.
 - 1959 Harry McCullough sold to Gerald Garnham.
 - 1962 Taxed to Chester A. + Althea C. Barker, owners 1974.

- No. 18 (old # 10) Map of 1854 gives Levi Putman who was in business with Leonard Charse and Robert Knight in the 1840s. Next owner was Frederick T. Sawyer who married in 1859 and the house was own by his family until his son F.W. Sawyer sold to William Fish in 1923.
- By 1927 it was taxed to Newton Baker and made into a three tenement house.
 - 1974 Owned by his daughters Sarah F. Baker + Ruth D. Wheeler

- No. 23 (old # 11) Not on the map of 1854. Map of 1892 gives Edward Finerty. He was very influencial in starting the Catholic Church in Milford and was Milford postmaster 1894-1898.
- 1927 taxed to Dr. Joseph Finerty.
- 1937 taxed to A.V. Phillips and in 1942 sold to Ernest Durant. He remodeled by lowering the very high ceilings and making apartments. The house burned in 1958 and rebuilt, burned again the second time and this time was rebuilt into a one-story house.
- 1974 Owners were Ernest and Eulalie Durant.

No. 24 (old # 12) Map of 1854 gives GEorge W. Burns He married in 1840 and died in 1889.
912 His widow sold to Dr. Eugene Wason.
1024 Durchased her Mr. + Mrs. Pattern

1924 Purchased by Mr + Mrs. Butler.

1929 Sold to John McEntee. The ell burned in 1940.

974 Owners John J. + Bridget E. McEntee.

(old # 15) Map of 1854 gives Dexter S. Burnham, who was a druggist in Eagle Hall. He also owned it in 1892 and 1901.
1913 It was taxed to Hattie D. (Burnham) Wright.
1941 Mrs. Harriet Savorypurchased the Wright place of Mrs. Sarah (Burnham) French of Nashua. Mrs. Savory sold in 1942.
1947 Taxed to Eleanora Carr.
1974 Owners Ai and Eleanora Carr.

No. 32 (old # 16) Map of 1854 gives W.W. Burns. He was married in 1847 and lived here a short time before moving to a farm in the Osgood District. The next owner was George H. Whitney who came to Milford in 1853 and died in 1884.

- 1885 Purchased by George Temple and he built an addition on the west in 1890. He owned in 1901.
- 1916 Irving Goodwin sold to William West.
- 1919 Chester Moore bought the house and he and later his widow were taxed for the house through 1857.
- 1962 It was taxed to Edward + Ann Hutchinson, who is 1964 sold to Robert F. Willette, owner in 1974.

No. 33 (old # 17) Map of 1854 gives Moses French who came to Milford in 1850 and died in 1889. Maps of 1892 and 1901 give his son Charles W. French as owner.
1914 He sold to Walter Frank Phelps.
1937 Taxed to Walter Poor through 1966.
1970 Taxed to William Koch, owner in 1974.

- No. 36 (old #18) 1884 the residence of Mrs. Charlotte Holmes was bought by Mrs. Benjamin ColEyank Loring moved in said residence. Frank Loring came to Milford in 1883.
- 1901 Frank Loring added a story to the extension on the east.
- It was owned by him and later his widow until her death in 1941. 1943 Purchased by Wilfred Davis and sold 1947.
- 1952 Ivy Martin taxed for _? .
- Dwned since 1962 by William Martin. He was the owner in 1974.

(old # 19) Map of 1854 gives Peter Clark, Jr. "came to Milford with his father in 1812, married in 1831 and died in the village in 1888." (But in 1973 he was living on Nashua Street so needs research)

1892 + 1901 Maps give J.A. Mixer as owner.

February 1920 Mixer sold his two story house to Michael Ansaldo.

1974 Owner is his daughter Angelina Ansaldo. She remodeled the barn in back of the house into a dwelling house.

SOUHEGAN STREET

(old #20) This may be the E.C. Wheeler house given on the 1854 map. As there was no Pleasant Street at that time it is difficult to place this house. E.C.Wheeler came to Milford in 1846 and died in 1896, but he lived other places in town some of the time.

- 1862 Stephen Coburn was living here as his daughter Grace was born her He was also living here in 1873.
- 1892 + 1901 Maps give E.P. Morgan owner.
- 1896 Mr. Towne moved from the Morgan house.
- 1905 This house was purchased at auction by G.A. McIntire, and he was taxed for it in 1913.
- 1922, It was purchased by George Winn, and in 1928 he advertised to rent "a 5 Room tenement". He was taxed for the place in 1937 (over)

and in 1942.

1947 It was taxed to Roland and Eva Levesque.

1956 They sold to Joseph and Dorothy Staite, who sold in 1961 to Russell and Virginai Fitzgerals. Taxed to them 1967. They were the owners in 1974.

SOUHEGAN STREET - PLEASANT TO CHESTNUT

- No. 39 (old #21) This was built in 1890 by James Mixer.
- 1897 Mrs. Nichols bought for a home for Louie Gilson.
- 1927 Taxed to Jennie Prior who bought it from Mixer in 1921.
- 1928 Arthur Prior sold to Harry Buxton.
- 1960 Buston sold to Henry Strout who sold before 1962.
- 1974 Owner, N.W. Carmen

SOUHEGAN STREET - PLEASANT TO Chestnut

No. 44 (old #22) This was the Franklin W. Sargent place on the map of 1892. He married in 1855, was an engineer who worked in the old Souhegan Mills. He died in 1904, and the place was owned by his widow, Mrs. Harriet E. Sargent.

1931 The Sargent place was sold to Harold and Ruth Dillon.

1974 Owner, ruth Dillon

SOUHEGAN STREET - PLEASANT TO CHESTNUT

The map of 1854 does not show any houses on the north side betwee what is now Pleasant and Chesnut so all the houses on that side of the street have been built since that date. There are two houses on the south side between the electric light station and the Amherst line. One, the John Proctor place, is just below the station and the other, the H.H. Farnsworth, is near the Amherst line.

 V_0 (old # 14) Built in 1926 by the United Co-operative Society and by December 1926 was ready for occupancy. The December 9, 1926 Cabinet has a picture and description of the block. The building has 50 ft. frontage on South Street and is 54 ft deep. It was designed by J.M.Gray + Co. of Boston architects and the Osgood consstruction of Nashua had the contract. It has two stories and a basement constructed of fire resisting design, even glass in the windows are of a specialkind which will not crack with the heat. The Co-operative gracery store will open Dec 11.

The United Co-operative Society was a stock company with directors. It first opened a store on South Street. By Dec 1922 it had added a meat department to their grocery store. 1924 The new directors of the Society were Andrew Young, John Kingston (over) Matti Kokko, and A.L.Prior. The surplus was near \$3000.

- Jan 1927 Mrs. Etta Pl.Koehler moved her millinery staor from the Stickney block to the small for the Co-op block.
- July 1928 New doughnut machine was turning our an average of 75 dozen & day.
- Nov. 1929 Paid 7% dividend.
- May 1930 Joined the Cloverleaf chain of stores and became self-service. Dec 1930 Robert Boak transfers from A & P to Co-op.
- April 20, 1933 The Sheriff closed the United Co-op store on South St. Oct 8. 1933 The Co-op society rented its market on South Street to the United Co-operative Society that operates five markets in the Fitchburg and Gardner.

SOUTH STREET Brick Block (continued)

Nov 1935 Mrs. W.H. Parker moved her hair dressing parlor from the small store and George Ellison moved in. Oct 1938 Ellison advertised home cooking Oct 1940 Dorothy Darling bought Ellison store and kept same line of goods and same name. 1942 To be operated under name of Darlings. Aug 1942 Fred Marshall is manager of Co-op Store Dec 1945 Mrs. Hauptman of Ponemah runs the village lunch in the small store.

Oct 5. 1944 John Morrison opened a new eletrial shop at 14 South Street in store now occupied by Darlings who moved to store formerly First National

March 1946 Co-op market to have self-service

- Aug 1949 Mr + Mrs Robert Woods of Bridge Street are now managers of Village Lunch.
- Oct 5, 1950 United Cooperative Society closes its doors.
- 1927 The top floor from 1927 to 1961-2 was occupied as a telephone

office. See Milford Cabinet for August 1927

- Kenmore Stamp Col occupied before the fire in 1966 unoccupied ever since (1974)
- July 13, 1967 The building was owned by Rosario Grasso. Before the fire in 1966 James Smith TV, County Commissioners and Grasso's barber shop occupied the first floor. After the fire and following repairs Gaults Pumbing moved into the north store. Lucier's TV had south store.
- 1952-1957 Owned by the MIlfordCo-operative Holding Co. INc. 1962-1967 Owned by Rosario and Dorothy Grasso.

- Nov 1, 1951 Louie Aveni opened a fruit and vegetable store. He had worked at the A & P for 11 years and for 8 years had own sales route in Milford, Wilton and Amherst.
- 1951 Arthur Fitt of Boston opened a jewelry shop in the small store. 1959 Fitt moved out and Rene Beauty Shop moved in.
- November 1960 The Coffee Shop opened at 14 South St. coffee breaks home cooked food and catering service. Open from 8am to6:30pm Monday through Saturday and Friday evenings. Plants from P.S. Florists. Mrs Margaret Stenborg was owner and manager
- July 13, 1967 The County Commissioners office closed its office and moved to Manchester.
- June 1974 A Reocrd Store opened at Lucier's former store. This was replaced in August ±975 by a grocery store. (over)

1975 Present owner, Walter Erikson.

No.64 (old # 16) Owned by Dr. Jonathan Hale 1793. He sold in 1797 to Dr. John Wallace, Jr. Wallace was bornin 1781, married 1809 and died in 1837. It may not have been the present brick house lathough several of the brick houses of Milford were built before 1830.

The next owner was George Daniels who came to Milford in 1837 from Manchester. He was connected with the Souhegan Cotton Mill. (See Milford Town History p.287, 288 381.) He died in 1881 and the property passed into the ownership of Josiah Pillsbury and his son Albert E. PIllsbury.

1920A.E. Pillsbury gave his home and furnishings to the Milford Society for Aged Women, Inc.. The Society occupied this building until 1933. At that time the Society moved to No. 95 (old # 15-17) High Street. (over) Since that date the house has had several differnt owners.

1975 The owners are Dr. alexandre G. and Augusta F. Law. They were first taxed for the house in 1954.

Dr. Alexandre G. Law has his office on the first floor and the upstairs is an apartment which is rented. This house has many of its old features left.

lo. 85 (old # 17) Not on the maps of 1854 or 1858.

1873 Owned by James F. Boynton who came to Milford in 1851. He owned the place when he died in 1899. He built the house.

lec. 1906 Purchased by Dr. E.H. Taft who was taxed for it in 1913.

1922 Dr. PLatts purchased of Sumner Hartshorn.

Sept 1926 Purchased by Mrs. Helen Foster and taxed to her in 1927 + 1937. Taxed to her estate in 1942.

Purchased by Dr. Joseph C. Jasper and taxed to Mrs. Helen B. Jasper

until 1961 when taxed to Helen B. and Joseph C. Jasper.

1963 Dr. Joseph Jasper sold to Dr. E.W. Mapes. .971 Dr. Mapes sold to Thomas J. Johnson.

1993 The house was razed. Area is now a parking lot for the bank.

No.80 (old #18) this was built about 1848 on land purchased from George Daniels. It was built and owned by F.J. French who was married in 1842. It later passed to his son William F. January 1974 is the propertyof his daughter, Miss Ruth French.

- Before 1830 there was a small house located in the very corner of South and High Streets.
- About 1832 a Lieut Smith moved into this house, third from Nashua St. The present Crusafelli Block was once a house facing South St) "When he was not engaged as a surveyor, or in some scientific matter he worked at tailoring." Milford Town History pp463,464 gives an interesting account of his life.
- Map 1854 Sometime this house passed into the ownership of William Hay. (over)

See Milford Town History p 734. He came to Milford in 1824 and died in 1862. He woned most of High Street hill at one time. His daughter Mary Hay owned until her death in 1884. W.F.French bought the land from her estate and built an ell to the main house.

The Hay house moved to (old #26) Oak Street.

- No. 123 (old # 19) House built by Ezra M. Gay who came to Milford in 1834. It is not shown of the maps of 1854 + 1858. He was living here is 1873 and 1895.
- 1894 he built a carriage house.
- 1902 or 3 He sold carriage house to the Christian Science Society and has been occupied by the church from that date. An addition was built on the front in 1963.
- August 1900 The house was purchased by George a. Jennison.
- 1904 He built a store house south of the house.
- 1913 Taxed to Mrs. Nellie Jennison.
- 1957 It was taxed to her heirs.
- 1962 Taced to heirs of Jacob Berzets.
- 1967 taxed to Mrs. Anna Goldman, present owner. (over)

1975 Owned by Robert Oxford. He remodeled the barn for use of their pottery business. They have named it The Fire Place.

No.114 (old # 20) The earliest record I have is from Josiah Crosby III to William Wallace. That will need some research. William Wallace married in 1822 aso probably took possession of this house about that date. 1854 William Wallace to Thomas Lane Vol.288 P70 1857 Thomas Lane to William Lane Vol.313 p197. Dec 6 1875 William Lane to Jesse Robinson Vol.425 p368 February 1876 Jacob Nichols who lately bought the Col. Lane house on

South Street is raising the ell and otherwise improving the buildings.

October 1881 Edward E. Foster purchased the Jacob Nichols house. 1885 Foster added two bay windows. It was willed to his daughter, Etta (FOster) Lovejoy. 1909 Samuel A. Lovejoy put in a bath room.

After Mrs. Lovejoy's death in 1933 it became the property of her son, Henry Foster Lovejoy, owner 1974.

Io. 130 (old #22) This property has been traced back to 1760 but I don't have the record.

Samuel Marvel sold to Nathan Cutter.

March 6, 1827 Nathan Cutter Estate advertised to sell the (prem) real estate of Nathan Cutter, later of Dunstable, situated near the Meeting House in Milford, in said county, consisting of about ½ A of land, with a dwelling house, two stories high and will finished and now occupied by Capt. Pliny Whitney. Whitney purchased and died here in 1873.

Nathan Cutter, by administrator to Pliny Whitney Vol. 150 P 483. Need to be searched. 1873 The Charles Whitney owner and in 1891 added a new piazza. He was the druggist of the firm Kidder and Whitney. (over)

- 929 Mrs. Mary J. Downs is improving the Whitney estate which she recently inherited making walks and banking up the lawn with field stones.
- By 1938 owned by Bridget A. Mahoney.
- 940 + 1947 taxed to Mary Hayward from Mahoney.
- 1952 Mary (Hayward) Antle
- 1957 taxed to Lyman + Frances Blake who sold in 1966 to Richard and Dorothy Messer.
- 1967 taxed to James + Loretta Durst who added a small apartment in ell and restored old features.
- 1971 Sold to John Cotney, present owner (1974)

No.147(old #23) Built by M.E. Bristoil. First taxed in 1959 as partial.

1972 Owned by Merle + Gertrude Bristol.
